We will strive to remain a "High Performer" agency and will continue to develop our relationships with local agencies that provide advocacy to our tenants, participants and applicants. The SHA continues its commitment to investing, and developing ideas and policies to increase and improve access of affordable housing to opportunity areas for racial/ethnic minorities, persons with disabilities families with children and other protected classes</p>

The Authority is maintaining 41 vouchers, after being under leased and administers 2 other vouchers in our area. Information from a 2017 ethnic composition of our area reports that 89% of the population is "white alone" and 11% is of racial/ethnic minority groups. Currently the SHA serves 57 individuals with its voucher allocation. 14% of the those served are from minority groups and 61% are persons with disabilities. The Authority will continue to</p>
